

## Burial request terms and conditions

### Definitions

Cemetery	All Cemeteries that are part of PC Uitvaart Locaties BV.: Begraafplaats en Crematorium Westgaarde located at Ookmeerweg 275 in Amsterdam. Begraafplaats Vredenhof located at Haarlemmerweg 367 in Amsterdam.
Funeral	A burial as referred to in the Corpse Handling Act and the associated services, including the provision of an auditorium, condolence room and family room during the time specified in the agreement and the performance of music (pieces).
The Grave	The grave as referred to in the application.
Client	The (legal) person who commissions the Cemetery to deliver goods and/or services, or receives an offer for this purpose.

### Article 1

The Client declares to have made the application in accordance with the (presumed) preferences and/or last will of the deceased.

### Article 2

The Client undertakes to comply with all provisions and procedures established or to be established by regulations in the interest of the funeral park or in another way.

Should the Client engage third parties, such as a funeral provider, in the implementation of the funeral, the Client will inform this third party of the terms and conditions of the Cemetery.

### Article 3

By signing the application, the Client is liable for the timely payment of all fees arising from this agreement.

### Article 4

The Client undertakes to provide all information of the deceased and himself relevant for the implementation of the application to the Cemetery in a timely manner. Relevant information include special medical treatments of the deceased with radioactive material. Pacemakers and defibrillators must be removed upon arrival at the Cemetery.

### Article 5

The Client must ensure the timely granting of leave to bury as referred to in the Corpse Handling Act, as well as all other necessary permits. The Cemetery reserves the right to postpone the Funeral until the Client has provided all necessary permits to the Cemetery. Costs in connection with this postponement will be charged by the Cemetery to the Client.

**Article 6**

If no use is made of the facility associated with a Funeral, this will not lead to a change in the price, unless explicitly agreed otherwise.

**Article 7**

If reserved times are exceeded, an additional fee will be charged to the Client, unless exceeding the time limit is attributable to the Cemetery.

**Article 8**

The Cemetery is entitled to set a maximum limit on the number of visitors who may enter certain rooms during the Funeral.

**Article 9**

Insofar as the Client is the beneficiary of the Grave, the Client hereby authorizes the Cemetery to bury the body of the deceased mentioned in the application in the Grave. Burial will not take place without an authorization from the Beneficiary of the Grave.

**Article 10**

Delivering a deceased person in a metal or plastic coffin is not permitted. The Cemetery is entitled to determine further conditions regarding the size, shape or quality of the coffin.

When transferring the deceased to the Cemetery, the face and limbs of the deceased must be completely covered.

The Cemetery reserves the right to refuse funerals. Funerals will be refused, among other things, if the legal requirements are not met.

**Article 11**

The Client warrants that there are no objects in the coffin that could cause damage to installations and other property of the Cemetery and/or the environment, such as alcohol, electronic equipment, medical devices and lighters.

**Article 12**

The applicant for a general grave – designated by the Cemetery as a user – has no control over the burial of other deceased persons in the same grave. General graves are issued for a period of 10 years. That period may not be extended. A general grave is eliminated after 10 years. The Cemetery is entitled to remove the remains from a general grave after elimination.

**Article 13**

The Cemetery performs the funeral or makes the other services listed on the application available at the prices stated on its rates list. If the Client cancels the agreed services, the Client shall owe the price stated on the rates list.

**Article 14**

Each service offered by the Cemetery is of a private nature and is therefore not open to the public. The officers designated by the Cemetery shall always have access to the rooms in use that are (or may be) part of the service.

**Article 15**

Serving your own refreshments during the Funeral is not permitted.

**Article 16**

The services provided by the Cemetery must be used in accordance with their intended purpose and with due observance of the provisions laid down in the regulations and guidelines and instructions of the Cemetery staff.

If the Client can reasonably foresee that the manner of implementation of the Funeral can lead to nuisance for third parties, the Client must inform the Cemetery in advance. Together, efforts will be made to limit the nuisance as much as possible. The Client is obliged to adapt the execution of the Funeral at the direction of the Cemetery.

**Article 17**

The general terms and conditions of PC Uitvaart Locaties BV filed with the Kamer van Koophandel in Amsterdam under number 33287156 apply to this agreement. Deviations only apply if these have been confirmed in writing by the Cemetery.
